In order to compare compliance with the required technical specifications and standards, the tendering economic operator must submit the catalogue(s) or extracts from the manufacturer's catalogue(s) for the list of goods subject to procurement, clearly indicating and specifying the materials to be offered. Note: The catalogue extracts must clearly and easily show that they are part of an official catalogue, as well as indicate to which catalogue and to which manufacturer they belong;
- 12. The economic operator must submit a European Certificate of Conformity (issued by the manufacturer), which verifies the technical data and the manufacturing standard in accordance with the requirements specified in the technical specifications;
- 13. The tendering economic operator must demonstrate that it owns or holds under contract a specialized service center for the maintenance and repair of the vehicles during the warranty period. a) For premises that are owned, the economic operator must submit documentation proving ownership. b) For leased premises, the economic operator must submit the lease agreement accompanied by the ownership document of the lessor.

- 14. The economic operator must submit a declaration of warranty for the offered goods, in which all terms and conditions of the manufacturer's technical warranty covered by the tenderer are clearly defined and described. The technical warranty period must be not less than 3 years or 100,000 km;
- 15. The economic operator must submit a declaration stating that it undertakes to complete the full delivery of the goods subject to procurement within thirty (30) days from the date of contract signing;
- 16. The economic operator must submit a declaration stating that it undertakes, at its own expense, to provide the vehicles with the complete documentation in the name of the Contracting Authority, as follows:
 - Vehicle registration certificate
 - Vehicle technical inspection certificate (where applicable)
 - Compulsory motor vehicle insurance policy
 - Annual circulation (road) taxes

The vehicle must be delivered to the National Civil Protection Agency, cleared through customs, with all obligations settled with the Tax Authorities. All customs expenses, registration, license plates, insurance, and vehicle inspection; the first scheduled technical services must be carried out free of charge for the first year (time required for concluding maintenance service contracts).
